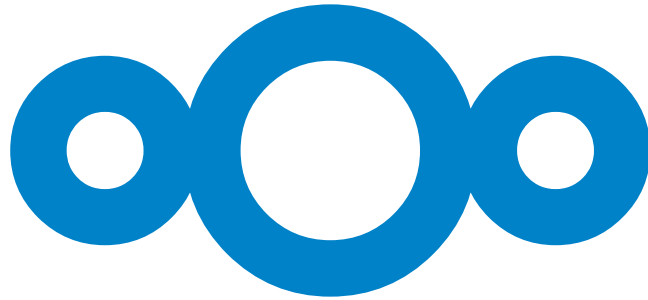
- Many new technology came up... and many more will come

- Level playing field which welcome everyone to contribute



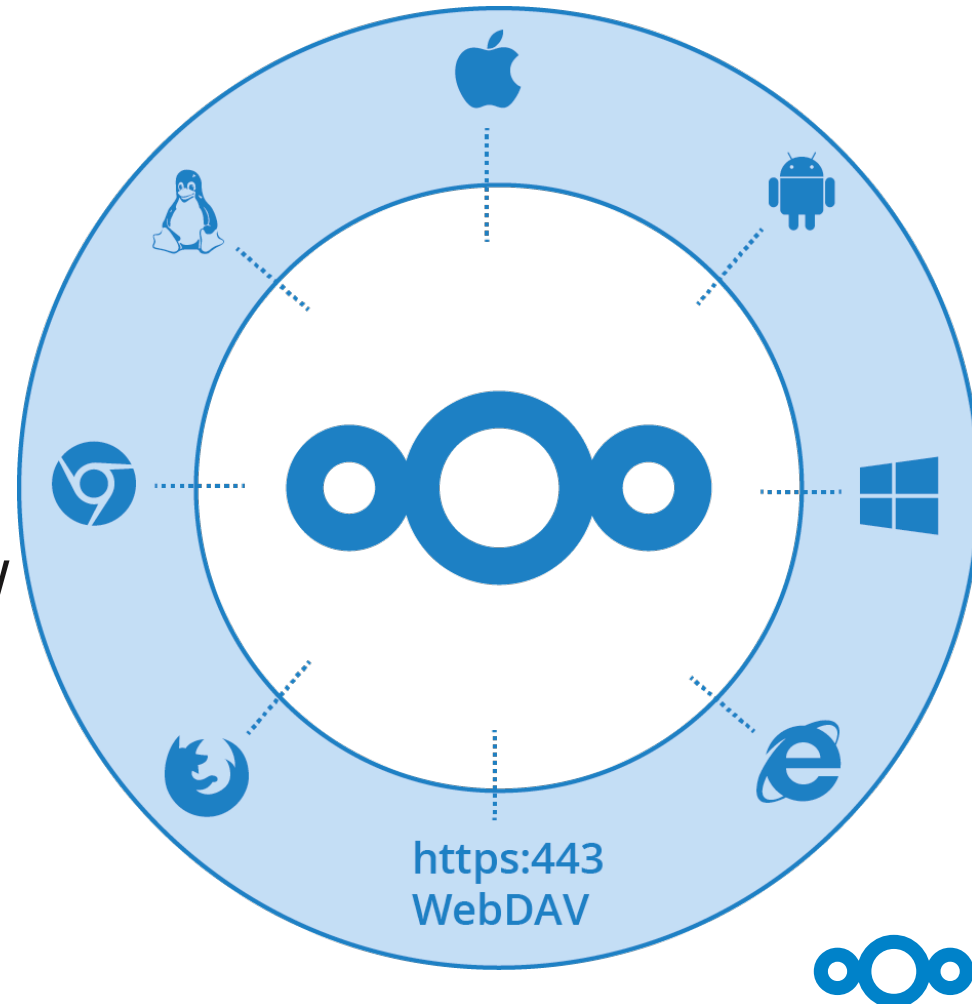
